### **Client Responsibilities Prior to Arrival at WPH:**

- \*Recommend horse is vaccinated with 4-way and tetanus and dewormed.
- \*It is strongly recommended that you horse's teeth be checked, wolf teeth pulled and teeth floated if needed.
- \*Horse must be in general good health and condition with no known transmittable diseases.
- \*If at any time WPH deems horse not healthy enough to continue in training, owner will be notified and no refund will be issued.
- \*WPH recommends health and mortality insurance on your horse. WPH will NOT be held responsible for ANY injury or death of horse while in training.

### **Boarding and Training Terms:**

- \*Training Rate - \$1200/month (30 days) + GST \$60 = \$1260.00.
  - \*First month training rate due on arrival of your horse. All accounts are on a monthly basis.
  - \***30 days Notice** is required to withdraw any horse from training. Client is responsible for the full training fee if horse is withdrawn without 30 days notice.
  - \*If at any time WPH deems a horse needing veterinary care, WPH has the right to ensure vet care is provided and attempts will be made to contact horse owner. If unable to contact owner in a timely manner (as deemed by WPH), veterinary care will be provided and billed directly to client.

\*WPH reserves the right to cancel training at any time if horse is deemed not healthy enough to continue training as determined by WPH or veterinarian. Any veterinarian costs incurred are the sole responsibility of the owner and will be billed directly to owner.

\*Any and all veterinarian services and supplies are the sole responsibility of the owner and will be billed directly to the owner.

\*Farrier services will be provided by WPH (unless otherwise discussed and agreed upon by WPH and horse owner) and will be billed to client. 4 Shoes \$140.00, 2 Shoes \$100.00 & Trim \$50.00

### **Clinics:**

\*Clinics hosted at WPH rates as posted with each event.

\*Clinics hosted at outside venues - \$350.00/day plus travel expenses at \$0.50/km. If any equipment requires hauling for clinic such as roping dummies etc. rates will be adjusted to include need for hauling trailer.

### **Horse Sale:**

\*Any sale of any horse in for training will result in, owner paying Carl Woods a 10% commission, over and above any training costs.

### **Lessons:**

\*Lessons are no extra charge for clients with horses currently in training with WPH with a maximum of 2-3 lessons per month of training.

\*Haul in lessons are \$50/hr.

\*Riders and spectators who come with horse owners recognize that riding is inherently dangerous and therefore you ride/spectate at your own risk. WPH will NOT be responsible for any injury or fatality to horse, rider or spectator.

### **Rehabilitation**

\*Any bandaging, wrapping, medication administration or other care required \$10/each time and will be billed directly to client.

\*Castration after-care by cold hosing and hand walking/lunging – No extra charge.

\*\*If at any time horse becomes injured for a period greater than 1 week, a rate of \$125.00/week board will be billed to client. Alternately, client can take horse home and return to complete training when horse fit. NO refunds for training.

## **Trainer Injury:**

\*If at any time WPH trainer becomes injured for a period greater than 1 week, a rate of \$125.00/week board will be billed to client. Alternately, client can take horse home and return to complete training when trainer fit. NO refunds for training.

## **Hauling Rates:**

\*Within Kelowna - \$75.00

\*With in Valley (Armstrong to Oliver) - \$150.00

\* Outside of Valley – \$0.50/km + \$20/hr travel time

\*Any horse that requires greater than 30 mins to load into trailer – client will be billed an additional \$50/hr.

**All accounts must be paid in full before horses are removed from training facility.**
